WAY TO GO KIDS! LICENSE AGREEMENT

IMPORTANT: THE WAY TO GO KIDS! PROGRAM IS LICENSED BY TLC NUTRITION, L.L.C. ON THE TERMS SET FORTH BELOW. YOUR SIGNATURE IN THE SPACE PROVIDED BELOW INDICATES YOUR ACCEPTANCE OF THESE TERMS. AGREEMENT TO THESE TERMS IS A PREREQUISITE TO ANY USE OF THE WAY TO GO KIDS! PROGRAM AND RELATED MATERIALS.

I. **LICENSE**

This License Agreement is a binding contract between TLC, Nutrition, L.L.C. ("TLC") and you. This License sets forth the terms and conditions on which you may use the WAY TO GO KIDS! ("WTGK!") program together with all teaching and instructional materials, forms and other related products and supplies (all of which are referred to in this License as "WTGK!") to be furnished to you by TLC. Please sign a copy of this License and return it to TLC. Upon acceptance of your order and execution of this License Agreement, TLC grants to you, and you accept, a non-exclusive license for use of WTGK!, its copyrighted materials, confidential information, trade secrets and registered trademarks, according to the terms set forth in this License Agreement. Your rights to use WTGK! are limited by this License. WTGK! and related materials shall remain the property of TLC, and must be used in accordance with the terms established by this License Agreement.

II. **COPYRIGHT**

WTGK! is copyrighted. You may not copy or otherwise reproduce any part of WTGK!, without written permission, except for the reproduction of materials specifically labeled to be copied. You may not distribute copies of WTGK!, permit any third party to use WTGK!, or create any derivative works from it.

You may not remove or conceal any trademark, copyright or other proprietary notice appearing on any copy or portion of WTGK!. You must reproduce any proprietary notices, trademarks or copyrights on any copies of any portion of WTGK! which you are permitted to make. You must include the WTGK! trademark, copyright and other proprietary notices on any portions of the product which are permitted to be distributed to your clients. You agree that you shall make note of the copyright and trademark of WTGK! when utilizing it in connection with any advertising.

III. **RESTRICTIONS ON USE AND TRANSFER**

You shall have complete discretion as to scheduling of your use of WTGK!, the price which you charge participants and the number and frequency of programs which you may undertake. WTGK! may not be associated with any strict or severe diet therapy, such as liquid formula or very low calorie diet.

TLC reserves the right to terminate this License Agreement in the event that it determines that any use of WTGK! is unethical, unprofessional, or in any other manner inconsistent with the intended use and purpose of WTGK! or if you fail or refuse to correct any such identified problem or deficiency within twenty (20) days of receipt of notice of any such deficiency or conduct. TLC may terminate this License immediately if you breach any of the terms and conditions specified in this License. If TLC terminates this License, you will promptly return all copies of WTGK! and related materials to TLC upon request. All provisions of this License relating to disclaimers of warranties, limitation of liability, remedies of damages and TLC's proprietary rights, shall survive termination. You may not assign this License without prior written approval from TLC.

You are licensed to use WTGK! through a single dietitian presenting the program at one or more locations, or through more than one dietitian presenting the program at a single location. You are not authorized to record the program or any portion thereof, in audio, video, electronic or any other medium. Any use of the program, which is not expressly authorized herein, or otherwise expressly authorized is in violation of this license and shall affect a revocation of the license granted hereby.

IV. **LIMITATION OF LIABILITY**

You hereby agree to indemnify and hold TLC harmless against all claims based on your improper use of WTGK! asserted by any of the participants of any program you conduct, their heirs, assigns or executors, if such improper use is contrary to any direction, counseling or information received from TLC in connection with WTGK!. In no case shall TLC's liability exceed the amount of the license fee. You acknowledge that TLC has not represented that you will earn a profit in excess of any consideration paid by you for WTGK!. **WTGK! is offered and delivered to you without warranty of any kind, either express or implied, including, but not limited to, the implied warranties of merchantability and fitness for a particular purpose, and the entire risk as to the quality and performance of the program is with you.**

V. **ADDITIONAL TERMS**

TLC will provide at no additional cost periodic contact and consultation for a 12 month period, including telephone support and assistance during initial set up of the program. In addition, TLC may provide updates, supplemental material, telephone support and consultation beyond the covered periods for reasonable charges to be established at the time the materials and service are acquired. There is no obligation to purchase additional materials or service.

You agree to provide statistical information, which may be requested from time to time, within reasonable limitations. Such statistical information shall not include any identifiers set forth for de-identification of protected health information pursuant to the Health Insurance Portability and Accountability Act (HIPAA). WTGK! will not disclose or provide to any third party any sensitive financial or competitive information concerning you or your use of WTGK!. The information which may be requested includes, without limitation, the number of participants in your programs, the amount of weight loss achieved, the percentage body fat lost, attendance records and other general information. The results of any research studies performed with this statistical information will be supplied by you to TLC Nutrition, LLC. You agree that such information may be included in research studies, the results of which may be published.

You acknowledge that WTGK! was created and designed to be taught by a registered dietitian. It is not intended to be taught by lay personnel. WTGK! must be taught in a manner consistent with the written materials provided. However, you are given the flexibility to add additional credible information which is published by professional organizations speaking to the relevant field, such as the American Medical Association, the American Dietetic Association, the American College of Sports Medicine, and like organizations.

You agree that you are not an employee or agent of TLC, and have no authority to bind TLC in any way. You further understand and agree that this License is not a distributorship or franchise offering, that your rights to use WTGK! are not exclusive, and that you do not have exclusive rights to use WTGK! in any territory or geographic area. This license authorizes use of WTGK! by a single dietitian at multiple facilities or by multiple dietitians at a single facility. You may not assign, sell, or otherwise transfer this license or any rights conferred hereby.

WTGK! shall have the right to collect from you its reasonable expenses and fees, including attorney's fees, which may be necessitated in enforcing this License Agreement. Any controversy or claim arising out of or relating to this License Agreement, or breach thereof, shall be settled by arbitration in accordance with the Rules of American Arbitration Association, and judgment upon the award rendered by the Arbitrator(s) may be entered in any United States Court having jurisdiction thereof. This License shall be governed and interpreted in accordance with the laws of the State of Alabama.
